John Spitkovsky grew up in the Chicago area and underwent a solid scholastic experience, graduated with honors from the city's parochial school system and ultimately attended the Illinois Institute of Technology. There, he received both a B.S. with honors and M.S. with high honors in Computer Science.

John started his computer career in 1983 in a college work program doing System's Programming at Rockwell International. It was here that he had his first exposure to the OpenVMS operating system and, more importantly, it was here that he met his original MSCS partner, David Meyer. Upon graduation, he accepted a full-time, permanent position at Rockwell International to administer a multi-site group of twenty Unix-based Computer-Aided Engineering (CAE) workstations. During this time, John started teaching night courses in

After six years of service at Rockwell and multiple promotions, John decided to move on, and accepted a position at Harris Bank. For two years, John was responsible for the setup, administration and management of an environment providing technical resources and programming support to the Investment Consulting & Analytics department, and the Harris Investment Management subsidiary. Not only did this provide him with exposure to the finance and investment industry, but this also gave him his first exposure to supervisory skills while managing an independent consultant.

Two years later, John accepted a Sales Engineer position working again with David Meyer at MTI Systems, a nationwide reseller for Digital Equipment Corporation, Hewlett Packard and Sun Microsystems hardware, software and services. After three years of service, supporting a \$12 million dollar budget, and becoming one of the top engineers in the company, John joined David and founded MS Consulting Services, a full-service IT consulting firm
